He who pays creates, he who pays nothing also creates nothing. Versailles Peace Treaty Art. 102 and Art. 103, Hague IV. Convention on Land Warfare Art. 43 with regard to the Corona coercive measures

Dear Chancellor Scholz,

he who pays creates, he who pays nothing creates.

Please sign that you accept personal responsibility for the additional costs of Corona measures, and all is well with the world. Refuse, and everyone knows that there is no justification for the Corona measures.

If a company boss wants his employee to get vaccinated, then the boss simply pays and takes responsibility in writing for known and as yet unknown side effects. That's the most natural thing in the world.

Where the hell is the infection center? I get my pack of coronavirus, go into quarantine and the corona shit is dead to me. The only thing I really believe is that my life will be fatal. Those who are afraid of that can go to solitary arrest under state care. For such people I also bear the costs.

But not for me to give up my life because others are afraid of it.

When the corona virus reached Italy, it was clear that sooner or later everyone would be infected with corona. There was talk of up to 10% deaths. This is a pandemic. The first lockdown was properly justified: It was necessary to slow down the spread so that the health care system would not be overburdened.

But then it very quickly became apparent that you don't die from Corona. Only debilitated people are at serious risk.

No emergency clinics have been set up. Thus, there is no emergency. No hazard allowances were paid. Thus, there is no danger. Forced measures are therefore not legal, but illegal. As long as my health insurance company does not see the need to propose a supplementary

As long as my health insurance company does not see the need to propose a supplementary insurance because of the coronavirus, where I decide whether to cover medical treatment by insurance or to treat myself, a democratic state has to stay out of my health care.

Now Salzburg notes that there is an incidence of 2000. Austrian television notes that within a

few weeks, since Sept. 2021, 18% of younger people are already infected.

But infected had already last year estimated 10- 15%. Vaccinated are 60%. Then 60+10(-15) +18% = 88 to 93% are already vaccinated or recovered.

20% infected in 10 weeks makes 100% in one year.

Already in 2019 Austrian physicians had demanded an increase of the budget in the amount of $1^000'000, -\epsilon$ to relieve the health care system. Nothing of this has been paid to date. If $2^000'000, 000, -\epsilon$ had been made available right at the beginning of the Corona outbreak, no Corona measures would have been necessary.

In Germany, 5,000 nurses have resigned. In Switzerland, the number of beds was reduced by almost a third in 2021.

Now, purely mathematically, 88-93% of the population is immune. Those who have been infected twice have the superimmunity that protects against all corona mutations - herd immunity.

But Mr. Chancellor Kurz has already proudly announced in Jan. 2021 that he has ordered 40,000,000 vaccine doses for 8,000,000 Austrians. In May, he announces that the coronavirus will be with us for another three years.

Obviously he has known that vaccination does not bring much. He has already ordered 3 x 2 vaccinations for every Austrian.

So natural immunity must not occur. What else to do with all the vaccinations?

To me the suspicion forces itself: There is something wrong.

Mr. Kurz is now ex-Chancellor because he is on trial. He bought the press with tax money. Mr. Adamah has researched that Bill Gates has bought the "news" magazine "Spiegel" with $2'000'000, -\epsilon$.

All this does not have to interest me.

I am a national of the most democratic state in the world.

You Mr. Chancellor Scholz hold on to your nationality of the national socialist German Reich. German policemen are freedom robbers according to EU law. This was stated by the ECJ on May 27,2019 based on a preliminary inquiry of two suspected Romanian bank robbers.

Towards "holders of German nationality in the meaning of Article 116 (1) of the Basic Law", German police officers are also freedom robbers. I am in the possession of the German nationality in the meaning of Article 116 paragraph 1 Basic Law (GG). And whether policemen with the nationality of the German Reich, i.e. Nazis are freedom robbers towards me, I naturally do not discuss with those who reject the nationality of the Federal Republic of Germany.

Of course, policemen with the nationality of the German Reich act correctly towards nationals of the German Reich.

Nobody has to argue with me about that.

If the Bavarian Police Tasks Act of 2018 had come into force, then the total SS state would have been re-established.

Mr. Weber the leader of the EPP in the EU Parliament, criticizes the Hungarian Fidez Party for its authoritarian leadership style. He wants the Fidez Party to be expelled from the EPP. Mrs. Hohlmeier, member of the EPP, then defends that the Fidez Party was not excluded from the EPP with the fact that one did not want to lose the votes of the Fidez Party so that Mr. Weber becomes EU Commission President.

Mrs. Hohlmeier is the daughter of the former Bavarian Prime Minister Strauss. He gave the GDR a loan of billions to keep the communist system running. He is said to have received a 1.5% brokerage fee for this. Perhaps someone remembers the Lockhead scandal. Lockhead had bribed all the defense ministers to buy the Starfighter. Only Mr. Strauss is said to have

been stupid enough to buy the Starfighter without being bribed.

Mr. Weber loudly criticizes the Polish judicial reform. Yet, after the judicial reform, Polish judges are still much more independent than Bavarian judges ever were.

Judicial independence in Bavaria has been completely eliminated.

The Bavarian CSU party, to which Mr. Weber and Mrs. Hohlmeier belong, is the de facto successor of the National Socialist German Workers' Party (NSDAP). Bavarian Prime Minister Söder is the spiritual successor of Reichsführer of the SS, Heinrich Himmler.

Mrs. von der Leyen has become President of the EU Commission. Her father was the former Prime Minister of Lower Saxony Albrecht. She deliberately rejects the nationality of the FRG, the free democratic state under the rule of law of the FRG, and thus the EU as an area of freedom and security under the rule of law.

Mr. Schäuble's daughter sits on the supervisory board of the public broadcasters. He was already in important government positions under Chancellor Kohl. He had illegal donations in custody that his boss Chancellor Kohl had received. Mr. Kohl lied before the investigating committee and then justified himself, saying he had had a blackout. He would not say from whom he had received the donations. He gave his "word of honor" that he would not name the donor. In the 70s, the joke was still allowed: "What is the difference between the Mafia and the CSU?" The answer: "The Mafia has a code of honor."

In Germany, 30,000 intensive care beds were available at the beginning of 2020, and only 20,000 at the end of 2020. Mrs. Merkel justifies the lockdown in March 2021 with literally "dramatic death figures." In fact, 11,000 fewer people died in March 2021 than in previous years.

On TV, it is claimed that 70'000 would have died of Corona in Germany. According to the official statistics 40'000. Without over-mortality? The evaluation of the causes of death shows that fewer people died of other diseases. The decrease is also 40'000. Now the public broadcasters report that according to the Federal Statistical Office there should have been an over-mortality. If I look at the statistics, more people have died at individual periods. But never peaks were reached, as they have already occurred in previous years.

But I hardly believe my eyes. Now the Federal Statistical Office plays oracle and predicts above-average death figures in advance.

Yet natural immunities have already emerged in the last year. 66% are vaccinated.

There is nevertheless something wrong.

According to my state law Section 839 of the Civil Code (BGB), the official is solely responsible for the legality of his actions. He cannot refer to laws if there are better alternatives.

I know exactly what I am writing about. As a probationary civil servant, I had to deal with a snow-break disaster. Funding guidelines were issued. According to these, pure spruce forests were also to be promoted. At a meeting of the funding measures, I said that I would not promote pure spruce forests. My superiors said, "If someone sues, you lose and have to pay." My response was, "I am the local official and I determine what tax dollars are used for." I convinced all forest owners to plant mixed forests.

The snowbreak disaster was followed by a bark beetle calamity. I went into private forests and cleaned up at the forest owners' expense. Also in a community of heirs with deputies as owners. My supervisor said, "You've stirred up a hornet's nest there." If my measures had cost more than if the forest farmers' association had done it, I would have been liable for the extra costs.

I was sued for damages because a tree had fallen on the road and damaged a passenger car. I was able to prove by witnesses that only a few months before, I had carried out a check to see if there was any suspicion that a tree might fall. I did not have to pay anything. The fact that a tree falls unexpectedly is part of the normal risk of life.

The legislator can spin this as he likes. The civil servant may not enforce a law if it violates the public policy of my state. Even if a law is permissible under the constitution, the official is liable if there is a more favorable solution.

My state is a democratic constitutional state. There is a separation of powers. The legislator is not above the civil servant. The official controls the legislator. Even if 99% of the population is in favor of a law that violates the ordre public, the civil servant does not enforce it. For that he is not dismissable. Who is dismissable, is not a civil servant and has no sovereign powers.

I am in possession of German nationality in the meaning of Article 116 (1) of the Basic Law and thus a national of the Federal Republic of Germany.

The FRG should be the legal successor of the Free City of Danzig. Under international law, however, this legal succession is only confirmed when I agree to a constitution for the FRG. This is also again expressly confirmed in Art. 1 of the 2 + 4 Treaty of 1990.

I have presented you a constitution in which the legal succession of the Free City of Danzig is regulated, but you do not sign it and do not present a counter-proposal.

You thereby declare to continue the war started by your grandfather and father.

Thus the Versailles Peace Treaty applies again. Art. 102 and Art. 103 and the Hague IV. Convention on Land Warfare, Art. 43 ordre public.

According to Art. 102 of the Peace Treaty, the Free City of Danzig is under the protection of the League of Nations. The Free City of Danzig can therefore never be a belligerent in the meaning of Section 1 of the Hague IV. Convention on Land Warfare. Therefore, Art. 43 ordre public of the Hague IV. Convention on Land Warfare (HLKO) always applies to anyone vis-à-vis a Danzig national.

According to Art. 103, the Constitution of the Free City of Danzig is an international treaty with the League of Nations, which guarantees the Constitution. This Constitution cannot be amended without the express consent of the League of Nations. Article 116 of the Danzig Constitution defines the ordre public of the Free City of Danzig as the German law at the time of 1920.

The enforcement of Corona coercive measures, therefore, constitute the criminal offense under Indictment No. 2 of the Nuremberg War Crimes Trials. That is, the loss of any right.

Anyone can enter the Free City of Danzig without a visa. That is, any European or Swiss can claim, at least temporarily, to be under Danzig law.

If you want to protect yourself from losing any right because your official violates the Hague IV. Convention towards a Danzig national, you have to apply for a Danzig identity card.

There is an easier way.

Just declare yourself ready to pay with personal signature the additional costs for Corona measures, if these costs are greater than a very good financing of the health care system.

You will say: Anyone could come along. But I'm not anybody. I am the court-approved representative of the Free City of Danzig, and for this reason I was arrested 7 times and spent over 2 years in prison. As you know and have acknowledged my claim is $160'000'000'000, -\epsilon$.

The ordinary citizen should go to the deputies, or to the party members of the ruling parties or to their representatives in the municipalities and cities. And of course, the police must personally sign to cover the additional costs, and so must every business owner.

The cost comparison will be made by an expert.

Anyone who refuses to accept personal liability and yet enforces corona measures will not only be liable for the damage, but will of course also have to pay substantial fines.

Why not surprise your compatriots? Nothing helps more against a severe course of corona infection like a positive surprise. Publish your declaration. Then everyone who trusts you blindly can sign himself without hesitation that he assumes liability.

Conclusion: At the very beginning of the corona crisis, I bought 20 kg of vitamin C for myself, my relatives and friends. I tried everything to infect myself. That's why I visited all kinds of people last year. In fact, when I return in the summer of 2020, I notice symptoms of a cold and I take a lot of vitamin C. The next day, the symptoms are gone. In the fall, the whole thing repeats itself. Can't be corona infection, I guess. I wonder where is the infection center. Where can I pick up my pack of coronavirus? Now one person is getting sick and has a fever. Maybe I'll get lucky now. As best as my time allows, I take care of the person. Always careful to infect myself. Secretly I always drink from the same glass. After a week of fever, I buy a quick corona test at my own expense. It turns out negative. But after a week of fever you should go to the doctor. He does a corona test. The laboratory reports a corona case. But I myself notice absolutely nothing even after 14 days. Probably I was infected with corona last year. Those who have survived an infection twice have a superimmunity that protects against all virus variants. I administer lvermectin to the sick person. I am not a doctor, and in Austria the health insurance fund has banned the sale of Ivermectin. In Germany, Ivermectin is not allowed to be used in hospitals. But if I take responsibility and can pay for mistakes, others can give a shit what I do. Vaccinations are given where it says on the package insert that it is an emergency approval. But there is no emergency. Vaccinations are being imposed where the package insert states that there may be unknown side effects. And I am not supposed to use a drug that has already been tested? Those who do not take responsibility and do not sign that they are liable belong under care to protect themselves and others. After Ivermectin was used in Mexico, hospitalizations with corona patients decreased by 85%. After taking Ivermectin, the condition ("of my patient") improves significantly. The fever decreases significantly.

Which countries have made the most progress against coronavirus so far? Among others, Sweden, Portugal, Brazil, even Great Britain is doing better than Germany. What have they done differently? They have not taken any corona measures or have done so relatively late. So natural immunity was already achieved before vaccination. Which countries are in the best position? Tanzania, for example. Nothing at all has been done there. But Mr. Lauterbach estimates that the coronavirus will accompany Germany for the next 4 years. Why? Because corona measures are imposed and vaccination is not done with coronaviruses, but with substances that do not really immunize. In contrast, the corona shit would have ended long ago in a controlled way if there were infection centers.

I have to buy masks at my own expense that affect my health and I pay for them through taxes for others. I co-pay via taxes for tests I don't need. I pay through taxes for vaccinations that I don't need. Measures that you and your friends want but I don't, you and your friends already have to pay for.

I do not pay taxes for your wishes. This is an expropriation. For the corona measures you have spent 400'000'000'000,-€ last year. That is about 4-5'000,-€/per head. That is for a welfare recipient almost the amount for a year of living, without rent. I would have preferred to give 10 welfare recipients a 10% increase in their budget. But of course I would also rather have paid the nursing staff better or donated to the starving.

Anyone who demands a service from another must pay for it. Anyone who does not pay for the service demanded is simply a criminal.

There is a distinction between fraudsters and predatory extortion. Whoever commits predatory extortion in a police uniform defiles the whole nation. He can be called a cowardly criminal scumbag, can't he? He should be punished especially severely, shouldn't he? What do you call someone who uses state power to override the rights of others?

Auschwitz was also the law. Only now is a secretary who worked in the Stutthof concentration camp being tried for aiding and abetting mass murder.

Do you believe that this woman is innocent? She was only doing a very simple job on a legal basis, wasn't she?

An official who does not take into account the fact that a foreigner is there at the behest of his or her state, i.e. who in fact has the status of a diplomat, is violating the general rules of international law. In this regard, no one enjoys immunity. The amount of the damage is debatable. They declare the world war to continue, The HLKO prevails. Whoever violates the HLKO loses all rights.

Please sign that you accept personal responsibility for the extra cost of corona measures, and all is well with the world. Refuse, and everyone knows there is no justification for corona measures.
